Hosted Retailers & Brands Program: Terms & Conditions (subject to change):

1. We will provide you with a complimentary ticket to attend Shoptalk Europe on 9-11 October 2017 at the Bella Center in Copenhagen. Your ticket provides access to all aspects of the event, including the exhibit hall, sessions, meals and networking receptions that are not private.
2. You agree to complete up to eight (8) 15-minute meetings (two hours of meetings) with Shoptalk Europe sponsors. You commit to be on-site and available during **all** of the following time slots:
 - o Monday, 9 October at 8:45-9:45 am
 - o Tuesday, 10 October at 10:40-11:40 am
 - o Tuesday, 10 October at 1:30-2:30 pm
 - o Wednesday, 11 October at 8:30-9:30 amShoptalk Europe will determine the specific times of your meetings.
3. We will contact you in advance of Shoptalk Europe to arrange your meetings. You agree to participate in this process, including (a) providing information about your company and role, (b) reviewing the list of sponsors and exhibitors that have selected you for meetings, (c) identifying any sponsors and exhibitors that you are unable to meet, (d) accepting calendar invites for meetings and (e) providing feedback on meetings. You also agree to respond to our requests within stated deadlines.
4. If you are unable to participate in the Hosted Retailers & Brands Program, you can cancel your participation without any penalty by letting us know by email no later than midnight GMT on Friday, 8 September 2017. You may suggest a substitute from your organization as a replacement subject to our prior email approval. If you cancel your participation in the Hosted Retailers & Brands Program after this deadline and are not able to provide a substitute approved by us, we will charge you €1,650 plus 25% VAT and not provide any travel reimbursement.
5. You are responsible for your own travel and accommodation arrangements for Shoptalk Europe. We are not able to guarantee the availability of our hotel room blocks, and recommend you book early.
6. If you are no longer employed or become aware that you will no longer be employed at the time of Shoptalk Europe by the retailer or brand based upon which you were approved to participate in the Hosted Retailers & Brands Program, you must let us know immediately upon you becoming aware so that we can cancel your participation in the program. You will no longer be eligible to participate in the program or to receive a travel/hotel reimbursement or complimentary Shoptalk Europe ticket.
7. Following Shoptalk Europe, please submit your receipts and we will provide you with a travel reimbursement of up to €650. Shoptalk Europe will not reimburse for any mileage, points or rewards used for travel. Reimbursement is conditioned upon you attending the up to eight meetings we identify for you.
8. You agree to provide your credit card information, and authorize us to process a €1 charge on your credit card as part of your registration. You also authorize us to charge the cost of your ticket (€1,650 plus 25% VAT) to your credit card if you do not (a) cancel in accordance with (4) above or (b) attend all your scheduled meetings.
